## Consumption tax on solar cells

Why did the US raise tariffs on solar cells?

The US government has decided to raise the tariff rates it applies to solar cells imported from China from 25% to 50%. "The tariff increase will protect against China's policy-driven overcapacitythat depresses prices and inhibits the development of solar capacity outside of China," the White House said in a statement.

What are the tariffs on solar cells?

As the tariffs on solar cells get increased to 50%, the USTR has proposed increasing tariffs on two subheadings, namely 2804.61.00 (for silicon containing by weight not less than 99.99% of silicon) and 3818.00.00 (chemical elements doped for use in electronics, in the form of discs, wafers etc., chemical compounds doped for electronical use).

Will tariffs on solar cells increase in 2024?

Will solar cell support be replaced by tax reduction for green technology?
