For commodities to successfully cross international borders, the correct HS code (also known as an HTS code) must be declared. This code determines the ...

In your letter dated October 5, 2021, you requested a tariff classification ruling. The merchandise under consideration is identified as the Power Supply Adapter, Model Number ZH-K009C-02400300-S-01W, which is described as a power supply for LED light strings.

The Customs Department started taking a view that the above definition excludes modules equipped with elements, such as diodes and produce DC power which can be directly connected to the load, hence mandating classification of solar modules under CTH 8501 3120 which reads as "Electric motors and generators" and hence imposing 7.5% customs duty ...
