Doha removes tariffs on solar cells

What if China imposes new solar tariffs on imports from Southeast Asia?

When the presidential moratorium on new solar tariffs on imports from Southeast Asia expires next June, imports of solar cells and modules from these five companies will be subject to the tariffs faced by Chinese solar manufacturers, with the tariff level ranging from 50 percent to 250 percent of the import value.

How will tariffs affect solar panels in 2025?

Tariffs on solar wafers,polysilicon,and certain tungsten products from China are going to rise dramaticallycome January 1st,2025,the Biden administration announced Wednesday. That means higher price tags on key materials needed to make solar panels at a time when solar is the fastest growing source of electricity in the US.

Can bifacial solar panels come through tariff-free?

But now, the first 12.5 GWof solar cells imported can come through tariff-free. Domestic panel manufacturers Hanwha Qcells, First Solar, Heliene, Suniva, Silfab, Crossroads Solar, Mission Solar and Auxin Solar petitioned the government earlier this year to extend the Sec. 201 tariffs and include bifacial panels in the order.

Will bifacial panels be included in Sec 201 tariffs?

Domestic panel manufacturers Hanwha Qcells, First Solar, Heliene, Suniva, Silfab, Crossroads Solar, Mission Solar and Auxin Solar petitioned the government earlier this year to extend the Sec. 201 tariffs and include bifacial panels in the order. Some of the petitioners requested a 20-GW TRQ, but the Biden Administration dialed it back to 12.5 GW.

Will Biden break tariffs on imported solar panels?

President Biden is giving the domestic solar panel manufacturing market a breakfrom tariffs on imported solar cells with the latest announcement from the White House.

Are solar panels tariffed?

Under the Sec. 201 tariffs, all imported solar cells and panels (regardless of country of origin, except for a few minor exceptions) are currently tariffed at 14.25% as a way to protect domestic solar panel manufacturers from cheaper product coming from overseas. Both monofacial and bifacial solar cells and panels are tariffed.

Now that the midterm report has been filed, only the President can make legal changes to the in-progress tariff. In February 2020, the USITC stated in its midterm report to President Trump only that the industry had seen mixed results from the Sec. 201 tariffs. Nine months later, the president chose to increase the tariff rate and remove bifacial's exemption.

The tariff rate on solar cells is set to increase from 25% to 50% in 2024. The new tariff plan includes the removal of the tariff exclusion for bifacial solar panels under Section 201 of the Trade Act of 1974. The
