Are lithium batteries dangerous?

For shipping, all types of lithium batteries are classified as dangerous goods-- with special regulations for packing, labelling, documentation and handling. Typically found in watches and cameras, they contain metallic lithium and are also called primary lithium batteries.

Can You ship lithium batteries by air?

In the United States, failure to comply with these regulations can result in a civil penalty of up to \$27,000 per offence (LBSR 1.3). Shipping lithium batteries by air is possible, but it is crucial to note these are dangerous goods and the applicable regulations must be complied with to ensure the safety of all personnel, aircraft, and passengers.

How do I ship a lithium battery?

To comply with Section II IATA shipping requirements, shipments containing lithium batteries and cells must comply with specific packaging guidelines. Ensure that lithium batteries are individually packaged in fully enclosed inner packagingsuch as a plastic blister wrap or pasteboard to provide protection for each battery.

What are the shipping requirements for lithium ion batteries?

In addition, lithium-ion cells and batteries shipped by themselves must be shipped at a state of charge not exceeding 30% of their rated capacity. Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations.

How should lithium batteries be packaged?

When preparing shipments containing lithium batteries, it is important to ensure the batteries are not in any way defective, damaged, or have the potential to produce a dangerous evolution of heat, fire or short circuit. When packaging lithium batteries for shipment, strong rigid outer packagingmust be used.
