Can a project be exempted from EIA requirements?

Article 2 (4) of the Environmental Impact Assessment (EIA) Directive provides for the possibility for Member States to exempt a specific project from the requirements of the Directive in 'exceptional cases'and,in such cases, for the possibility of using an alternative form of assessment.

What is an environmental impact assessment (EIA)?

With its wide scope and broad purpose, the EIA ensures that environmental concerns are considered from the very beginning of new building or development projects, or their changes or extensions. It allows the public to actively engage in the EIA procedure. The first Environmental Impact Assessment Directive (85/337/EEC) came into force in 1985.
