# Solar Photovoltaic Panel Equipment Transfer Contract

Can a provider sell a photovoltaic system to a customer?

WHEREAS, Provider has offered, at his sole cost and expense, to install, maintain, own, replace, repair, and operate a photovoltaic system at one or more of the Property (ies) and to sell Solar Services (as hereafter defined) produced by the solar photovoltaic system to Customer as provided in and subject to the provisions of this Agreement.

Do solar projects need an EPC contract?

In our experience, most utility-scale solar projects use an EPC Contract. An operation and maintenance agreement: This is usually a medium- to long-term Operating and Maintenance Agreement (O&M Agreement) with an Operator. The term of the O&M Agreement will vary from project to project.

What is a solar panel purchase contract?

A solar panel purchase contract is an agreement whereby the Owner purchases (310 watt DC) solar photovoltaic panels, called Owner's Solar Panels, from Developerfor a total price of \$1,178 per panel.

What are the different types of solar panel agreements & proposals?

There are different types of solar panel agreements and proposals available. The one you use will depend on a few different factors. These factors include whether you lease or buy solar panels and whether the contract is for a home, business, or even a large development. A power purchase agreement or PPA is similar to a solar lease agreement.

Will EPC contracts provide for the handover of a solar facility?

EPC Contracts will notprovide for the handover of the solar facility to the Project Company, and the PPA will not become effective until all commissioning and reliability trialling has been successfully completed.

What is a solar contract?

Solar Contracts are fine-tuned for small and medium-sized,grid-connected solar PV projects. Standardised contracts include: Power Purchase Agreement,Implementation Agreement,O&M Agreement,Supply Agreement,Installation Agreement and Finance Facility Term Sheet. These are complemented by the Implementation Guidelines.
