Will Longi repurchase 600 million yuan shares?

Longi Green Energy Technology Co., the world's largest solar equipment maker, plans to repurchase as much as 600 million yuan (\$83 million) of its Shanghai-listed shares, the company said Monday. That follows Tongwei Co. 's proposal for a 2 billion yuan buyback last week, and an earlier move by JinkoSolar Holding Co.

Will China's share buybacks stop a slump in solar market valuations?

Efforts by China's solar manufacturers to use share buybacks to arrest a slump in market valuations are expected to have only a limited impact, with the sector facing continued pressure on profits.

How do I calculate the coverage ratio of a solar project?

This is done by taking the net present value (NPV) of the after-tax cash flows using an 8.5% discount rate. The second method is to calculate the amount that yields a 1.18xcoverage ratio. How does a bank finance a solar system?

The Bank buys the solar system from the Developer and then leases it back. In doing so, the Bank is able to take the Investment Tax Credit and accelerated depreciation. It passes the benefit back to the Developer in the form of lower lease payments. Said another way: the Bank monetizes the tax credit, so the Developer doesn't need Tax Equity.
