Resident companies are taxed on gains or profits accrued directly or indirectly from all sources in Saint Lucia and are subject to tax at a flat rate of 30%. The 30% tax rate is only applicable to companies that, prior to income year 2003, have no tax arrears and have complied with the requirements of any enactment administered by the Inland Revenue Department ...

Examples of these in St. Lucia are community shops, grocers, a car wash or a bar. It is set up quite easily. Under the Registration of Business Names Act, every person who is carrying on business in St. Lucia under a name other than their own name must register with the Registry of Companies and Intellectual Property.
